Ornamental Landscaping

- Please let George know if you have suggestions on ways to improve maintenance activities within the district.
- Landscape Enhancement Projects are scheduled to proceed in mid February. The project will continue on Carmel Country Road, focusing on the slopes and right-of-ways.
- WCA has completed the Tree Inventory Data Collection process for CV #10 MAD. The Tree Inventory established a value of approximately \$1,721,200.00 in tree assets throughout the MAD. Tree trimming will start in late February and continue on Carmel Country Road. WCA has recommended no further treatment for the declining Silk Trees. A reassessment will take place later this spring.
- Attached is a quote from Treebeard for the installation of smart controllers, master valves and flow sensors in the MAD. There are 192 total irrigation stations in the MAD. At \$55 per station the estimated rebate amount is \$10,560. The total cost to the MAD is estimated to be about \$30,000, or \$4,100 per controller/master valve/flow sensor install.
